- ➤ Joly has put forward a proposal for a hub using the Sundridge Public School. Al Bottomley will join Bruce Baker, Chris Ellis and Lyle Hall for a tour of the school on Friday, March 24, 2017 at noon.
- In preparation for the AMO Conference in August, Lyles asked that Council consider a delegation to further the engineering of Main Street and will pursue this at a future date.
- ➤ Colleen Anderson is the recipient of a Governor General Award. Lyle has been asked to present the award to her, and will do so at the June 3<sup>rd</sup> Volunteer Event. Council, through Don Richardson and Jason Newman, will plan the event, estimating that at \$1,000 budget is required. Lyle will bring forward a Notice of Motion for same on April 12, 2017.

## Russell Becker

- ➤ The joint Recreation group is very enthusiastic about a Black Fly Mud Runner event. Al Bottomley has suggested that the NNDSB school trails could be used, and encouraged cooperation with the school board to have obstacles built, etc.
- ➤ It is felt that a registration fee of \$65 to \$70 per participant is realistic
- ➤ Grants need to be secured for seed money the group will work with CAEDA to see if administrative support might be provided through them.
