- ➤ The Township of Machar is banning phosphate fertilizer to curb the effect of Blue-Green algae on lakes.
- ➤ Dr. Jim Chirico presented at the spring DPSMA meeting. Marihuana legislation is now moved from July to September. Municipalities will be given \$10,000 for implementation of enforcement requirements.
- ➤ The Health Unit building is on schedule and under budget. It will be paid off n 2 years. The Health Unit will be receiving a 2% increase in funding.
- Census data shows a 4% increase of seniors (65+) in the area. The average wage in Parry Sound is \$15.84/hr. As of April 18, 2018, 540 jobs were posted and not filled.
- ➤ A Fresh Mart is opening in South River on August 20, 2018. They have been granted a 10-year tax break by the Village.
- ➤ The Almaguin Highlands Health Committee may be acquiring a social worker to join the health team in Burk's Falls.
- ➤ Ice damage on Lake Bernard shoreline is the worst ever this year. MNR will not change the dam. A meeting is taking lace on May 18, 2018 with Strong Township, Village of Sundridge and property owners.
- ➤ East Parry Sound will attend a meeting on May 24, 2018 at the Burk's Falls hospital to discuss implications of proposed changes to the Huntsville Hospital.
